Self-employed Borrower Business Verification	Self-employed borrowers must have their business verified as open and operating within 30 calendar days prior to the Note date. Documentation must be provided with one of the following to confirm that the business is open and operating: <ul style="list-style-type: none"> <li>• Evidence of current work (executed contracts or signed invoices that indicate the business is operating on the day the correspondent verifies self-employment)</li> <li>• Evidence of current business receipts within 30 days of the Note date (payment for services performed)</li> <li>• Correspondent certification that the business is open and operating (correspondent confirmed through a phone call or other means)</li> <li>• Business website demonstrating activity supporting current business operations (timely appointments for estimates or service can be scheduled)</li> </ul>
